ANNUAL TRAVEL - Only available at time of enrollment in the Health Care Plan

Out of province/country emergency medical benefits

- Unlimited trips of up to 30, 45, 60, 90, 120, 150 or 180 days each
- Can change trip duration annually at renewal
- ✓ \$5 million of coverage per person, per trip
- ✓ No age limit
- Top-Up days or per trip travel is available directly through RSA

LIFE INSURANCE - Enrollment Age 50 – 80

\$5,000 - \$20,000 – available to Retiree & Spouse

- ✓ Guaranteed coverage no medical required, once enrolled premiums never change
- ✓ Living benefit −if terminally ill
- ✓ Joint and survivor coverage 5% savings on premiums
- Accidental death up to 5 times the benefit amount to max of \$100,000

CONVALESCENT CARE - Enrollment Age 50 – 80

Financial assistance for the many costs associated with recovering at home

- Home nursing, transportation and medical equipment
- Pre/post-operative expenses related to cataract surgery
